\*The daily rate fee is \$66 for drop-in or part-time schedules. We accept WCCC & CCAP child care subsidies.

\*A \$20 non-refundable deposit per week is required at the time of registration which will apply towards your weekly camp rate. Summer Camp fees are due 2 weeks in advance of the camp. Fees includes camp, all activities, breakfast, and an afternoon snack. Children should bring a balanced lunch and appropriate clothes for the weather and activities.
