## **PINEHURST SCHOOL AGE & PRESCHOOL PROGRAM TUITION AGREEMENT**

1. Tuition fees for the entire month, including summer months, are payable in advance and are due on the 1<sup>st</sup> of the month. If received after the 5<sup>th</sup>, a late fee of \$25.00 is added.
2. We use Tuition Express for electronic payments from either a checking or savings account. To participate, complete the *Tuition Express Authorization Form* and submit with a voided check. Tuition Express is processed on the 5<sup>th</sup> of each month or the first business day after, if the 5<sup>th</sup> is a weekend or holiday.
3. Pre-approved drop-in care, for currently enrolled part-time children, is payable on the day the care is received and is dependent on enrollment capacity.
4. There is a \$25.00 charge for any non-sufficient fund (NSF) checks or declined payments through Tuition Express.
5. No refunds or account credits are given for absences due to illness, federal holidays, the day after Thanksgiving, the extra closure days over Winter Break, staff in-service days, weather related closures, natural disasters, closures required by state licensing requirements (due to power outages, plumbing issues, etc.) or personal reasons.
6. There is a 10% discount on the second child's tuition when there are two or more children from the same family attending 5 mornings and 5 afternoons or 5 full days per month.
7. The *Registration Form, Payment and Enrollment Agreement* and *Certificate of Immunization Status (CIS) Form* must be filled out and submitted before a child enters care.
8. School year tuition is based on a 10-month school year, not including summer camp. 100% tuition will be charged September – June.
9. Full day programming provided on specific non-school days (see current Pinehurst calendar for full day program dates) is provided for an additional fee.
10. Our program opens at 7:00am on school days and 7:30am on non-school days. We close at 6:00pm on school days and 5:30pm on non-school days. A late fee of \$1.00 per minute will be charged to your account for any late pick-ups after our closing time.
11. Notices of withdrawal from the program must be given one month in advance of the last scheduled day of enrollment. Changes to your child's monthly schedule must be requested 2 weeks in advance.
12. Families are charged an annual non-refundable Registration Fee of \$75 to secure a spot for the school year.
13. Pinehurst participates in the Child Care Assistance Subsidy Program, Working Connections Child Care Program, and subsidy programs offered through Child Care Resources. Contact the Director for more information.
